# Auction Dates: October 15 thru November 17, 2018

Many of the stallions listed on this website, you will find, have been proven in many Industries and many talented young up and comers. You will find Arena Record holders, NFR Qualifiers, NFR producers, Cutting & Reining Champions. An awesome variety for any breeder who is shopping for a quality stallion.

# THANK YOU TO ALL THE STALLION OWNERS FOR YOUR DONATION! It is because of you, this futurity has become the largest California has ever seen!

90% of the money raised from this auction will go to the C-N California Futurity, Derby, and Incentives held February 23-24, 2019, at the Chowchilla Fairgrounds. Standard Pattern. Excellent Ground. Perfect for the young horse. Last year paid out more than \$80,000 in Cash and Prizes in just 2 days. The stallion service auction brought in a total of over \$40,000 alone. We also had over \$20,000 in incentives.

10% of the Auction money raised will go into an insurance account. A running total will be kept on the website page for all to view. This money will be to protect Stallion owner and Bidders. A claim can be submitted for a refund of your auction. It will be up to the C-N Board to decide if refund for auction will be granted. Such refunds will be for death of stallion without exchange.

An insurance claim cannot be used if mare simply does not take or death of mare. This is only if stallion is unable to complete his obligation due to death or semen count. Or if stallion owner does not fulfill contract obligations. This insurance is to protect the stallion owner as well as the bidder.

All insurance claims must be submitted by June first of the year prior to the closing of the auction. Once claims are closed the remaining money, if not all, will be added to the next years incentive program and futurity. Or donated to another futurity as a C-N Incentive side pot payout. Distribution will depend on the amount that is remaining as of June 1.

## **Bidding Rules:**

Each Stallion Bid will start at \$200. First Bid must be a minimum of \$225 to start the bidding process on a stallion. Intermittent

### How do you bid:

You MUST fill out a bid form and submit to cbarnfuturity@gmail.com.

You will be required to submit a credit card number to secure your bid. A 4% charge will be added if your credit card is charged at the end of the auction. You are able to make other payment arrangements once the auction is over. You will have 2 weeks to submit payment or make arrangements or your credit card will be charged.

Bids must be in minimum \$25.00 increments.

You must include your NAME, The STALLION you wish to bid on, Your BID AMOUNT, and CONTACT INFORMATION. Any bid placed lacking this information will not be accepted.

On the last day of the auction, November 17, 2018, you <u>MUST CALL IN YOUR BID ONLY</u>. Voice or Text messages will <u>NOT</u> be accepted. You MUST speak to a live person. Several phone numbers and operators will be available on the website (www.cbarnquarterhorses.com) on the last day of the auction.

#### How the Max Bid works:

If a Stallion's high bid is at \$400 (with no max bid set) and you wish to place a bid not to exceed \$600 you may give a max bid of \$600. Your current bid will be \$425 to take the current high bid. Each time an individual bids on the stallion your bid will automatically be bumped \$25.00 until you hit your max bid of \$600. At which time you will need to call in a new bid if you wish to continue. For Example:

Current High Bid \$400 (with no max bid)

Jane Doe bids \$425 with a max bid of \$600.

Billy Joe bids \$450

Jane Doe's bid will automatically bump to \$475, she will continue as the high bidder Billy Joe will have to call in another bid to continue.

If Billy Joe requests to bid \$600, he will be contacted that a max bid of that same amount has already been placed and Jane Doe will keep the High bid. Billy Joe will then have to call back to place a new bid if he wishes to proceed.

### On The Last Day of Bidding:

#### **VERY IMPORTANT TO ALL ACTIVE BIDDERS**

# Auction will close at 6pm PST on November 17, 2018 HOWEVER:

"BIDDING" will continue until 5 consecutive minutes have gone by WITHOUT any bids on ANY stallion.

For Example:

If a bid comes in at 5:58pm

# **BIDDING WILL SCHEDULE TO CLOSE AT 6:03pm "IF" no other bids come in**

"IF" a bid comes in at or before 6:02pm (or any time before the 6:03pm cut off), the bidding will remain open an additional 5 minutes (closing at 6:08pm) and so on until 5 consecutive minutes of ZERO bids have been called in

This means the auction could actually end as early as 9pm or later.

So keep an eye on your stallion if you don't want to miss out.

The last minutes of the auction it is CRUCIAL to hit "REFRESH" on your computer OFTEN so not to miss out on a bid.

ALL BIDDERS will be kept confidential until the end of the auction...

ALL BIDDER and Bid Amounts will be posted in detail at the end of the auction on the website within 24 hours of the closing of the auction.

Be sure you KNOW how much your bid was and keep an eye on the website for updates. You will be responsible for your own bid(s).

<u>ALL fees must be paid to C-N Quarter Horses by December 1, 2018.</u> If fees are not paid or arrangements are not made by December 1, 2017, your auction will be offered to the next highest bidder.

**Breeding Arrangements with Stallion!** 

PLEASE make arrangements with the stallion owner in a <u>TIMELY MANNER</u>. Do NOT wait until your mare is due to be bred. Stallion Owners need sufficient notice to prepare the collection of their stallion. This means once you receive your Stallion Auction Breeders Certificate contact the stallion owner and give details on your breeding plans for 2018. This means no later than February 1 if at all possible. You will keep one copy of the certificate for yourself and give the 2<sup>nd</sup> copy to the stallion owner when requested or at the time of breeding.

ALL WINNERS and bidders will be posted no later than November 19, 2017 on the website.

This auction covers breeding fee ONLY!

Any mare care or vet requirements such as AI, shipment, chute Fee, must be discussed with the stallion owner and/or veterinarian. There is a stipulations sheet on the website that will show fees to some of the stallions. If the stipulations for a stallion are blank, please contact the owner for any added fees or breeding requirements.

WHEN CONTACTING THE STALLION OWNER I ASK THAT YOU BE KIND AND RESPECTFUL OF THEIR BREEDING PROGRAM. THIS AUCTION IS BECAUSE OF THEM.
