We are heading into our 16<sup>th</sup> Annual C-N Stallion Service Auction and California Futurity. With each year we have learned, grown, and expanded to accommodate so many different avenues. 2010 marks the year of our first Stallion Service Auction where 8 local stallions were donated raising \$4,800 for the futurity. Now raising the bar to close to over \$60,000 and welcomed in 100+ stallions across the United States, Australia, and Canada. A Stallion Incentive Program for eligible stallions and futurity horses was implemented in 2014. The program has continued to grow and pays out more each year. 2025 Paid out over \$116,000!

We would like to invite you to come aboard and donate a breeding or Buy In to the C-N Stallion Service Auction. In return for your generous donation, the C-N Stallion Incentive Program can offer several things:

1. Commitment:

With a 3 years commitment to donating a breeding to the C-N Stallion Service Auction your stallion and his offspring are immediately eligible for the Stallion Incentive Program. (Please read rules on website for details [www.cbarnquarterhorses.com](http://www.cbarnquarterhorses.com)). After 3 years your stallion **will continue in the program unless you notify our office of any changes you would like to make.**

2. C-N and Stallion Owner Commitments:

- a) Random Facebook blasts and links of the stallions on the C-N California Futurity Facebook page. Please tag C-N so we can share your posts.
- b) Stallion Service Auction Facebook share contests. Gifts are donated by C-N Quarter Horses (In past years we reached over 18,000-barrel racers from a single contest post). Excellent advertising for your stallion.
- c) A link from the C-N California Stallion website directly to your website and/or Facebook page.
- d) A Picture of your stallion will be posted on the [www.cbarnquarterhorses.com](http://www.cbarnquarterhorses.com) website along with his pedigree from [www.allbreedpedigree.com](http://www.allbreedpedigree.com) or your personal link
- e) Your banner will have a spot in the arena during the warmup race and the entire Futurity weekend (provided by stallion owner). We can return after the race at your request.
- f) Stallion will be listed in the C-N California Futurity Program
- g) Stallion and Ranch name will be announced throughout the weekend during the Futurity race.
- h) If provided, a High-Definition Flyer or photo of your stallion(s) will be added to the Nation Webcast put together by JF Videos.
- i) If provided, we will add your flyer or business card in our Futurity gift bags. Over 100 given away.

3. 90% of ALL money raised through the entire Futurity Program will go back to the Futurity and Derby Incentive Program in March 2026 and each year as donated. 10% Will be retained to an account for insurance to protect the C-N Incentive Stallion owners and bidders. Please read the rules for more detailed information on protection insurance.
4. All stallion bids start with a \$300 bid; **If your stallion does not get a bid, you, the stallion owner, will be responsible for the minimum bid of \$300.**
5. The stallion owner can set stipulations on the stallion donated. You may disclose your added fees such as Chute Fee, Shipping Fee, Mare Care, breeding dates, etc., as well as your breeding preference such as AI or Live Cover. You can put anything you wish the bidder to know in this section. We try to allow no funds to come out of your pocket if you so choose.
6. C-N California Futurity is open to hearing new ideas we may possibly be able to implement to help you, the Stallion owner as well as expanding to make this Futurity the best it can be.
7. C-N California Futurity will provide a Breeders Certificate to the winner of your stallion with all your contact information. It states in part, breeding is not transferable, may not be sold, or traded without the stallion owner's approval.
8. After 5 years of consecutive donating your stallion MAY become eligible for our grandfather option if your stallion retired from breeding for one of the following reasons: Can no longer ship semen due to semen count. Medically retired. Does not breed to the public for any reason. Or Death. If said stallion becomes medically unable to breed for a specific reason, he and his offspring are still eligible to remain in the Stallion Incentive Program for a discounted price of 65% of current year stud fee or last advertised stud fee.
9. We encourage all stallion owners to provide a banner for your stallion which will be put up every year your stallion is in the Program. The average cost for a banner is approx. \$80. It looks very nice and will be visible to the Webcast Camera and photographer during the futurity weekend.
10. **VERY IMPORTANT**.....if you wish to pull your stallion from the Incentive Program **YOU MUST** contact C-N California Futurity in writing at [Cbarnfuturity@gmail.com](mailto:Cbarnfuturity@gmail.com) or mail to 17117 Iona Avenue Lemoore, CA 93245.
11. You **MUST** contact C-N if ownership of stallion changes hands. If you do not and stallion is sold in the auction, you are responsible for any and all fees acquired by stallion in the auction, fulfillment of this contract, and a refund or breeding transfer to the winning bidder. **PLEASE INITIAL:**

\_\_\_\_\_ **You are agreeing to donate stallion for a minimum of 3 years.** In return stallion and offspring will be eligible for the C-N Stallion Incentive Program for as long as the stallion is donated. If you choose not to agree to the 3-year agreement, offspring will have the option to buy in for the years stallion was donated only.

\_\_\_\_\_ **If your stallion is in the C-N Stallion Auction and does not sell during the auction, you as the owner is required to pay a fee of \$300 to keep stallion active in the Incentive Program.**

\_\_\_\_\_ **I agree to fill out the 'Stallion Change Form' on the C-N Website if any of the enrolled stallion information has changed, or if stallion is sold and C-N is not informed. If auction information of enrolled stallion is not current, this may result in stallion owner paying the non-sale fee of \$300. If buyer fails to pay due to incorrect information. This includes all current enrolled Incentives.**

**PLEASE CHOOSE ONE AND INITIAL:**

\_\_\_\_\_ I agree to the minimum 3-year stallion service donation. In return, myself and any offspring to stallion entered in the C-N California Futurity during the years the stallion is donated will receive all eligibilities to the C-N Stallion Incentive Program. A Banner spot will be saved in the arena at every C-N Futurity produced.

\_\_\_\_\_ I agree to Buy In to the Stallion Incentive Program without donating a breeding to the auction. I agree to pay half of my stallion's current year stud fee or \$1,000, whichever is less, for a minimum of 3years. Payment must be submitted by January 30th of each year to be eligible for the Incentive Program. A Banner spot will be saved in the arena at every C-N Futurity produced. All the same advertising perks will apply.

\_\_\_\_\_ I do not wish to be a part of the C-N Stallion Incentive Program at this time, however, would like to donate a breeding to the October-November 2025 C-N Stallion Service Auction. Advertising will apply during the auction.

**MUST READ AND INITIAL BELOW...**

\_\_\_\_\_ If you wish to pull your stallion from the Incentive Program ***you must contact C-N California Futurity*** in writing at [Cbarnfuturity@gmail.com](mailto:Cbarnfuturity@gmail.com) or mail to 17117 Iona Avenue Lemoore, CA 93245. Otherwise, ***your stallion will continue in the program each year.*** If you pull out before your required contract agreement stallion owner will be obligated to pay the buy in penalty of \$300 for remaining contract year(s).

It is understood that 90% of the money raised through the C-N Stallion Service Auction will go directly to the C-N California Futurity added money and Stallion Incentive Program. 10% will be retained for Auction insurance to cover Breeder and stallion owner from certain instances beyond their control. This is to protect the Stallion Owner and Bidder.

C-N California Futurity, directors, or volunteers will not be held responsible for accidents to any mare/foal while they are at the court of the stallion.

C-N California Futurity will not be responsible for any mare that does not retain pregnancy.
